


How to Evaluate a Sales Tax Software Solution

System reliability so your site never slows down

System performance and reliability should be one of, if not the biggest, factor in choosing a sales tax solution provider. Accurate, real-time sales tax rates

There are thousands of product tax codes to determine product taxability and over 14,000 sales tax jurisdictions in the U.S. That's why it's important that your sales tax software solution provides accurate, real-time, rooftop-level rates upon checkout.

In some states, your business may have economic nexus, requiring you to collect sales tax... and in other states your business may have physical nexus with a warehouse or office location, again requiring you to collect sales tax. Easy to use sales tax reporting & automated filing


Once you've collected accurate sales tax rates with an API that doesn't slow down your website, it's important to file sales tax returns to every state where you have nexus — on time and accurately..

Whether you're a multi-channel merchant with advanced order-to-cash processes or a fast-growing SaaS company, make sure that the pricing model and impact on transactions and API calls is straightforward. For example, an order-based pricing model is determined by the number of monthly transactions processed and an API usage model (which allows for a ratio of sales tax calculations to orders - like 10 sales tax calculations equals one order). On the other hand, a percentage- based model takes a fee out of every transaction. An order-based pricing model can save you thousands of dollars.

In addition, be sure that your sales tax solution provider doesn't charge extra fees for support and implementation. Will you get the help you need to navigate any learning curves and stay ahead?


